PSWC Board of Directors is comprised of twelve members, three members each representing the Town of Brownville, Town of Milo, Lake View Plantation and Piscataquis County.

## **YOU MUST DISPLAY A PSWC STICKER ON YOUR VEHICLE TO ACCESS THE SITE**

Contact your local town office to obtain a sticker. If you live in one of the unorganized territories listed, you can get one at the Brownville Town Office.

**IF YOU DISAGREE WITH THE ATTENDANT(S) ON DUTY, FOR ANY REASON, INCLUDING BUT NOT LIMITED TO:**

- THE FEE(S) CHARGED TO YOU
- REFUSAL TO DISPOSE OF ANY PORTION OF YOUR LOAD OR
- REFUSAL TO ACCESS THE SITE FOR ANY REASON

**YOU MAY NOT, UNDER ANY CIRCUMSTANCES:**

- RAISE YOUR VOICE TO THE ATTENDANTS
- THREATEN THE ATTENDANTS OR
- IN ANY WAY HARASS THE ATTENDANTS WORKING HERE

**YOU MAY:**

- CONVEY YOUR CONCERN OR DISAGREEMENT TO THE PSWC BOARD OF DIRECTORS (GENERALLY MEET THE 2<sup>ND</sup> WEDNESDAY EACH MONTH) OR
- CONTACT A REPRESENTATIVE OF YOUR TOWN, PLANTATION OR UNORGANIZED TERRITORY AS LISTED ON THE BACK OF THIS FORM.

**IF YOU EXHIBIT ANY OF THE ABOVE INAPPROPRIATE BEHAVIOR, THE ATTENDANTS HAVE BEEN INSTRUCTED, BY THE PSWC BOARD OF DIRECTORS, TO CONTACT 9-1-1 TO DISPATCH LAW ENFORCEMENT.**

**SITE ATTENDANTS ARE FOLLOWING GUIDELINES AND PROCEDURES ESTABLISHED BY THE PSWC BOARD OF DIRECTORS. ENFORCEMENT OF THOSE PROCEDURES DO NOT AFFORD ANYONE THE RIGHT TO TREAT THEM DISRESPECTFULLY.**

**DEPENDING ON THE SEVERITY OF THE BEHAVIOR, YOUR PRIVILEGES TO USE THE PSWC SITE MAY BE TEMPORARILY OR PERMANENTLY REVOKED BY THE PSWC BOARD OF DIRECTORS.**
